



Notice is hereby given that any qualified person who desires to be a candidate for Director of the Pettis County Ambulance District from the following election districts may have his/her name placed upon the ballot by filing his/her written declaration of such candidacy in the office of the County Clerk of Pettis County. The opening filing date is 8:00 a.m. on December 06, 2022, and the closing filing date is 5:00 p.m. on December 27, 2022. Filings will be received Monday through Friday.

Anyone who is at least twenty-four (24) years of age, a citizen of the United States, a qualified voter who resides in the election district of the Pettis County Ambulance District for which he/she wishes to be a candidate, and a resident of the Ambulance District for two years prior to the election, is qualified to be a candidate for one of the following election districts of the Pettis County Ambulance District.
